

HOW DO I QUALIFY?

The investor is not required to speak English, have prior business experience, or demonstrate a minimum level of education. The only requirement is that the investor has the required net worth and capital. You may live and work in your home country as long as you travel to the U.S. every 180 days and keep a U.S. domicile. If you choose to live in the U.S., you may live anywhere in the U.S. This means you have the freedom to send your children to school anywhere in the U.S.

IS EB-5 TRULY A PASSIVE INVESTMENT?

The EB-5 regulations require involvement in management or policy making. The regulations deem a limited partner in a limited partnership, which is properly structured and that conforms to the Uniform Limited Partnership Act, as sufficiently engaged in the EB-5 enterprise.
